Training – I agree –

1. 6. Miriam Henke Consulting reserves the right to change the training venue at any point prior to the training in order to best serve the needs of the students.

Course and Program payments –

1. Students are required to pay for their courses in full at least two weeks prior to the commencement date. Payments can be made via instalment plan by negotiation with Miriam Henke.

7. If paying the course fees by instalments, if two of those instalments are missed then the whole amount of the course fee immediately becomes due & payable.
8. Failure to make payments as agreed will result in all recovery costs being the responsibility of the student and become due to Miriam Henke Consulting.
